Evelyn Warr Cummings, Marion Regional Planning, explained that they go through environmental process for asbestos survey. Rose Cottage, at Sawyer Ludwig, is coated on the outside with asbestos. Because it is on the outside and the building otherwise in safe condition, they cannot just tear it all down and call it hot. They have to go through the process of abatement. They had projected \$5,000 and bid came in at \$18,000. This is for abatement only, not demolition. She will come back with that proposal. Abatement will be funded out of Parks and Recreation. This is out of formula/allocation grant. They have about \$60,000 for Sawyer Ludwig.

Safety Director Robbins clarified that 568 Decatur is owned by John DeWolf. He went to prison and the bank foreclosed on rental properties and the bank took possession of the properties that they wanted.

Mr. Schaber offered to assist Mr. Daniels after the meeting to talk with the County Land Bank, which has limited funds.
